Get Prepared for SASB Reporting

The Sustainability Accounting Standards Board (SASB), founded in 2011, created a framework for disclosing financially material ESG factors. They identified five broad dimensions across 77 industries, then selected the most relevant topics within the dimensions to ensure disclosures focus on material risks and opportunities. The standards help companies report issues that directly affect financial performance.



Strategic Clarity: Quickly understand which issues drive financial performance in your industry. Benchmark against peers and competitors to identify strengths and blind spots.



Align Strategy with Investor Expectations: Signal sustainability awareness and progress. Build confidence with stakeholders by communicating to stakeholders the relevant sustainability factors.



Get a Head Start: Use the SASB materiality measures to map internal risks and data gaps, before reporting publicly. Reduce future compliance costs by setting up systems early.
