- ✓ Quickly and accurately test if you comply with the TNFD market-led framework. How will your company compare to your peers?
- ✓ **Decide where to place focus.** Scan topics and look for weak spots. See which sustainability areas you need to focus on now.
- ✓ **Choose your own threshold.** Do you want to be in step with your peers or be best in class? Set goals you can meet rather than absolute targets.
- ✓ **Protect your brand.** Make sure your company attracts praise instead of criticism. Avoid risks and take advantage of opportunities.

Get Prepared for TNFD

The Taskforce on Nature Related Financial Disclosures (TNFD) framework was announced in 2020 by the World Economic Forum and its founding partners. The goal of the TNFD is to provide a global framework for organizations to identify, assess, manage, and disclose nature-related risks and opportunities, so that financial and business decisions support nature-positive outcomes and long-term resilience. Organizations use TNFD to manage and disclose risks and opportunities, and align with global sustainability expectations.

Strategic Clarity: Your company receives an early understanding of exposure. Identify where nature might matter most (water use, waste etc.).

Build Credibility with Better Reporting: Signal a forward-looking stance aligned with global reporting trends. Communicate to stakeholders that your company is aware of nature-related risks.

Get a Head Start: Laying the groundwork now makes later data integration faster and less expensive. Focus on what's material before investing in data or tools.
